JOHN GOOLEVIN (or Gullivan) This cause coming on to be heard on the bill and answer and Cross Bill and Answer thereto and testimony taken in open Court, and counsel for the plaintiff in the Cross Bill of complaint announcing in Open Court that the said Cross Bill could be considered as dismissed or withdrawn by leave of Court, counsel for the respective parties were heard and the proceedings were by the Court carefully read and considered; It is thereupon this 14th day of March, 1914, "by the Circuit Court No. 2 of Baltimore City, adjudged, ordered and decreed that the said John Gullivan, the plaintiff in the Original Bill, be, and he is hereby, divorced a vinculo mattrimonii from Annie Gullivan, the defendant, and that the said plaintiff be and he is hereby awarded the care and custody of the infant children, James, John, Charles and Thomas, mentioned in the proceedings, until the further order of the Court; And it is further adjudged, ordered and decreed that the Cross Bill of complaint filed by the said Annie Gullivan or Goolevin be, and it is hereby, dismissed, and this Court retains jurisdiction of Agnes Gullivan, the infant daughter of the said John Gullivan and Annie Gullivan. And it is further Ordered that the said John Gullivan
